Incident Information: 12/29/2022
<p>Misconduct 12/29/2022 8:10 PM</p> <p>Several inmates were seen inside a cell, which is a violation within OJC. Every inmate, with the exception of the inmates housed in that cell, was repeatedly asked to leave the cell to no avail. Assistance was called to remove the defiant inmates without further incident.</p>
<p>Attempted Escape 12/29/2022 9:40 AM</p> <p>A deputy was leaving a pod. As the door of the pod was closing behind them, an inmate pushed the door back open, forcing the deputy back as well. The inmate refused all directives to step back on the pod. The deputy headed toward the main corridor of the floor to notify supervisors and the inmate followed as well. The inmate was escorted back to the cell once the floor supervisors were made aware.</p>
<p>Misconduct 12/29/2022 2:14 PM</p> <p>Two cellmates were having a verbal altercation about one of their belongings. A deputy intervened to de-escalate. Once separated, one inmate began damaging the other inmate's belongings. The inmate was removed from the cell and written up.</p>
<p>Use of Force 12/29/2022 9:06 PM</p> <p>An inmate was instructed to lockdown into their cell, the inmate repeatedly refused instruction. When deputies attempted to escort the inmate back to their cell, they were again met with defiance. The deputies restrained the inmate eventually bringing them to the ground and applying handcuffs. The inmate refused any medical evaluations and was escorted back to their cell without further incident.</p>

An inmate stated to a deputy that they may have had a stroke. The deputy notified medical staff and was instructed to escort the inmate to medical. The inmate was evaluated and cleared to return to the pod.

An inmate grabbed a deputy multiple times and touched them inappropriately. The inmate was pushed for separation away from the deputy. Assistance was called to escort the inmate back to their cell without further incident.

An inmate was found to have a knife concealed in their possession. The weapon was confiscated and the inmate written up.

Use of Force
12/30/2022 8:06 PM

An inmate was being openly defiant on their pod. Repeatedly refusing instructions to lock down, eating food from trays that were not theirs, hanging from the pod railings and throwing feces at deputies. Assistance arrived on the pod to restrain the inmate. The inmate was forced to the ground, handcuffed and escorted back to their cell.

An inmate hit another inmate. The inmates were asked to lockdown until medical staff could come to evaluate and clear them. The aggressive inmate repeatedly refused and became irate. Assistance was already on the pod to assist and began restraining the inmate in order to bring them back to their cell.

Incident Information: 12/31/2022

An inmate was instructed to close the trap on their cell door. They repeatedly refused and began throwing fecal matter from the trap door. Their trap door was closed and the inmate was written up.

An inmate notified a deputy that their shoulder was in pain and possibly out of place. The inmate was escorted to medical to be evaluated.

An inmate was seen with a wick in their cell. The deputy entered the cell to confiscate the wick, the inmate flushed it. The inmate was written up.

The deputy gained possession of the toilet paper and proceeded to inspect it. The deputy found contraband within the raveling of the toiler paper. The inmate was locked down and written up.</p>
