Incident Information: 1/13/2023
Medical 1/13/2023 6:00 AM
A deputy noticed a blood stain on an inmate's pillow. Medical staff was called to examine the inmate. After the examination, the inmate was routed to University Medical Center for further treatment.
Use of Force 1/13/2023 11:33 PM
An inmate was given several instructions to exit their cell to no avail. The inmate remained on their bed. The inmate was then restrained by deputies and escorted off the pod without further incident.
Misconduct 1/13/2023 12:00 PM
An inmate threw a water bottle filled with bodily fluids and other unknown substances onto a deputy.

An inmate was seen making inappropriate gestures from their cell.

An inmate refused to go back into their cell after repeated instructions to do so.

An inmate's cell door was opened to collect food trays. Once the door was opened, the inmate forced their way past the deputy and started a fight with another inmate. They were separated shortly after and escorted off the pod.

An inmate was observed being unresponsive. Medical staff was notified and showed up to examine the inmate. After the examination, it was determined that the inmate would be routed to University Medical Center for further treatment.

An inmate was observed inflicting harm to their self. Medical staff was called to examine the condition of the inmate. It was determined that the inmate would be routed to University Medical Center.

A deputy noticed an inmate with a head injury. The inmate was unaware of the injury, confused, disoriented and incoherent in his responses. Medical staff was called to examine the inmate's condition. It was determined that the inmate would be routed to University Medical Center.

An arrested subject was refusing the thorough search prior to entering the facility. The arrested subject then began making threats to spit on the searching deputy. The deputy then held the head and neck area of the subject to prevent spitting to continue their search. The subject eventually calmed down and the deputy was able to finish their search and accept the subject.

A deputy reviewed camera footage of two inmates having a physical altercation in a cell. Both inmates exited the cell without any further incident. This took place before any deputies were aware of the incident. Both inmates were escorted to medical and interviewed regarding the incident.

Two inmates were involved in a physical altercation. The altercation was over by the time back up arrived to break it up. Both inmates were escorted to medical, one refused attention and the other was routed to University Medical Center.

A deputy arrived on the pod to a commotion where several inmates were restraining an inmate from advancing toward another inmate. The aggressive inmate stated that the other inmate had spit on them. The deputy noticed spit on the inmate's uniform. The other inmate was locked down and written up.

Three inmates were involved in a physical altercation. An inmate was seen on camera walking up to another inmate with an unknown item. As the inmate got within range, the other inmate began fighting with the inmate. The inmate began using the unknown item in a stabbing motion towards the other inmate. As this was happening, a third inmate is seen entering the altercation to assist the inmate in striking the other inmate. The inmates were separated and locked down. The inmate that was stabbed was taken to see medical staff for examination and treatment.

An inmate was being escorted to medical to no avail. The inmate refused to be handcuffed for the escorting until they were threatened with OC Spray. They were handcuffed and escorted without further incident.

Contraband

An inmate was seen with a burning wick inside their cell. Upon further inspection, the deputy could see the inmate using one wick to light another. The deputy gave commands to put the wicks out to no avail. The inmate repeatedly refused the commands until the deputy entered the cell. The inmate put the wicks out and flushed them.

Inmate on Staff Altercation/Use of Force

An inmate was being escorted into their cell when they became aggressive and struck the deputy. The cell door was then closed, locking the inmate down.

Two cellmates were seen having a physical altercation. By the time deputies arrived it had ceased. The inmates were separated and brought to medical for examination and cleared to return to the pod.

An inmate was seen with a lit wick in their cell. The inmate flushed the wick before it could be confiscated.

An inmate repeatedly refused their housing assignment.

An inmate was seen having a seizure on the floor of their cell. The inmate was placed on a stretcher and escorted to medical for examination and treatment before being cleared to return to the pod.

An inmate repeatedly refused their housing assignment.

Contraband
1/18/2023 12:04 PM

An inmate was observed to be in possession of prescription drugs without a prescription. The drugs were confiscated, the inmate was searched and written up.

Two cells were found to have smoke coming from them. Upon further investigation, the source of the smoke had been flushed before being confiscated. The inmates were written up.
